In addition to this information, in order to guarantee the correct and transparent processing of your data, you must be aware of the fact that:


- The duration of the treatment is determined as follows: 5 years from the date of termination of the contract (Article 2948 of the Civil Code which provides for the 5-year prescription)

- Has the right to lodge a complaint with the following Supervisory Authority: Guarantor for the
